

# If You Bought Johnson & Johnson Bedtime Bath Products You May be Entitled to Cash from a Class Action Settlement

A proposed settlement has been reached in a class action lawsuit about the labeling and packaging of some of Johnson & Johnson's Bedtime Bath Products. The Plaintiff in the lawsuit claims that Johnson & Johnson mislabeled some of its Bedtime Bath Products by describing them as "clinically proven" to help a baby sleep better.

### Am I a Class Member?

You are a Class Member if you bought at least one of the eligible Johnson & Johnson Bedtime Bath Products, within Canada, since **July 1, 2010** for individual or household use and not for resale. ### What Can I Get From the Settlement?

A fund of \$600,000.00 CAD will be created to pay Class Members for a portion of the cost of the Bedtime Bath Products they purchased, for notice and claim administration costs, attorneys' fees and expenses and incentive payment to the Class Representative. Johnson & Johnson also made changes to the labels for the affected Bedtime Bath Products in December 2016 and 2017 and to its website in 2017.

Settlement Class Members may submit a properly completed Claim Form and be eligible to receive a cash refund of up to \$3 CAD for each eligible Bedtime Bath Product purchased, up to 5 Products per household, without any proof of purchase. These awards may be subject to *pro rata* upward or downward adjustment depending on the number of claims approved. ### What are My Options?

1. You can accept the Settlement and remain in the class. To ask for a cash payment and stay in the Class, you **MUST** file a claim online no later than **April 6, 2018**. **File a CLAIM ONLINE** at [www.babybedtimesettlement.ca](http://www.babybedtimesettlement.ca) or obtain a Claim Form by calling 1-844-562-4215 or email a request

2. If you do not wish to participate in the settlement, you may exclude yourself from the Class (opt out) no later than **April 6, 2018**. If you exclude yourself, you can't get money from this settlement if it is approved.

3. If you're a Class Member, you may also object to any part of the settlement you don't like, no later than **December 29, 2017**, and the Court will consider your views. Your objection must be timely, in writing and must provide evidence of your membership in the Class.

The Court will hold a Hearing at 9:30 a.m. on **January 29, 2018** in Montreal, Province of Quebec, Canada. At this hearing, the Court will consider whether the settlement is fair, reasonable and adequate and whether to approve the Class Representative's incentive award of \$500.00 CAD and the attorneys' fees and expenses. You may attend the hearing, and you may hire your own lawyer, but you are not required to do either. The Court will consider timely written objections and will listen to people who have made a prior written request to speak at the hearing. After the hearing, the Court will decide whether to approve the settlement.
